## 2021 KENOSHA KINGFISH AND NORTH SHORE BANK "LEGENDARY" SWEEPSTAKES

## **OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE STATE OF WISCONSIN OR WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE STATE OF WISCONSIN ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE STATE OF WISCONSIN AT THE TIME OF ENTRY. Entry Period: The 2021 Kenosha Kingfish and North Shore Bank "Legendary" Sweepstakes (the "Sweepstakes") commences at 2:00 p.m. Central Standard Time ("CST") on August 11, 2021 and ends at 11:59 p.m. CST on August 19, 2021 (the "Sweepstakes Period"). The Co-Sponsors' time clock will be the official time keeping device for this Sweepstakes. All entries must be received by 11:59 p.m. CST on August 19, 2021. All interpretations of these Official Rules and decisions made by Co-Sponsors relating to the Sweepstakes are final.
- 2. Eligibility: To be eligible to enter the Sweepstakes you must be a legal resident of the United States residing in the state of Wisconsin and at least 18 years of age at time of entry. Employees, agents, and directors of North Shore Bank, and Kenosha Kingfish (the "Co-Sponsors"), and Margle Media, LLC (the "Administrator"), and their respective parent companies, affiliated companies, subsidiaries, partners, sponsors, advertising agencies, promotion agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes (the "Sweepstakes Entities"), and their immediate families (i.e., parents, spouse, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to enter or win the Sweepstakes.
- **3.** By participating in this Sweepstakes, entrant: (a) agrees to be bound by these Official Rules and by the interpretations of these Official Rules by the Co-Sponsors and by the

decisions of the Co-Sponsors; (b) acknowledges compliance with these Official Rules; (c) represents and warrants that he or she meets all the eligibility criteria set forth in these Official Rules; (d) agrees to comply with any and all applicable federal, state and local laws, rules and regulations; and (e) agrees to indemnify and hold harmless the Sweepstakes Entities, Facebook, and Instagram (the "Released Parties") from and against any and all liability arising out of or relating in any way to entrant's participation in Sweepstakes and to release all rights to bring any claim, action or proceeding against the Released Parties. - 4. To Enter: During the Sweepstakes Period, eligible entrants are required to (i) enter your information at northshorebank.com/legendsgiveaway and (ii) visit the Kenosha Kingfish Facebook page and North Shore Bank Facebook page and "Like" each page or visit the Kenosha Kingfish Instagram page and North Shore Bank Instagram page and "Follow" each page. By completing these tasks, entrants will earn one (1) entry into the Sweepstakes. There is a limit of one (1) entry per person during the Sweepstakes **Period.** In the event of a dispute over the identity of the person who submitted a winning entry, the information entered at northshorebank.com/tastegiveaway will be deemed to be the entrant. It is the sole responsibility of the entrant to notify the Administrator in writing if the entrant changes his or her Facebook or Instagram account during the Sweepstakes Period. The "authorized account subscriber" for online entries is defined as the natural person who is assigned a social media account by a social media platform provider, online service provider or other organization that is responsible for assigning social media accounts or handles for the account associated with the submitted Facebook or Instagram account. In the event a winning account selected is a joint account, a total of one (1) Prize will be awarded in the name of the information entered at northshorebank.com/tastegiveaway. Proof to Sponsor's satisfaction of being the authorized account subscriber may be required by Sponsor. All entries submitted in compliance with these Official Rules and not disqualified are considered eligible entries ("Eligible Entries"). purposes, and may be used for administrative, promotional and marketing purposes associated with the Sweepstakes.

- **6. Odds of Winning:** The odds of winning the Sweepstakes depend on the total number of Eligible Entries received during the Sweepstakes Period.
- 7. Prizes: One (1) Prize will be randomly awarded in total. Prize consists of four (4) tickets to both the 8/27/2021 Celebrity Softball Game and 8/28/2021 Home Run Derby at Historic Simmons Field, and four hats and two jerseys. The Approximate Retail Value ("ARV") of the Prize is \$280. All federal, state, and local taxes on a Prize are the sole responsibility of the Winner. Prize is not transferable, and no substitution or cash equivalent is allowed, except in Co-Sponsors' sole discretion. Co-Sponsors reserve the right to substitute prize of the same approximate retail value if advertised Prize becomes unavailable for any reason. Prize consists only of items specifically listed as part of the Prize. Winner is responsible for all costs and expenses associated with Prize acceptance and use that are not specified herein as being awarded. Prize dates are subject to change in Sponsor's sole discretion. - 8. Publicity Release: Except where prohibited by law, by participating in Sweepstakes, the Winner grants to the Co-Sponsors, and their representatives, affiliates, licensees and assigns, the right and permission to record, film, videotape and photograph the Winner (the "Images"). These Images will be owned by the Co-Sponsors. Administrator will attempt to contact the potential Winner via email and/or phone within **three (3) business days** of winner selection. By entering the Sweepstakes, the entrant hereby grants permission to be contacted via email. If a potential Winner cannot be reached directly or does not respond

within **three business (3) days** of initial e-mail and/or does not meet the eligibility requirements, the potential Winner will be disqualified, and an alternate potential Winner will be selected in a random drawing from among all of the remaining Eligible Entries.

10.
