OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE STATE OF WISCONSIN OR WHERE PROHIBITED OR RESTRICTED BY LAW. Entry Period: The 2021 Shorewood Business Improvement District (BID) and North Shore Bank "Shorewood Feast" Sweepstakes (the "Sweepstakes") commences at 8:00 a.m. Central Standard Time ("CST") on August 25, 2021 and ends at 11:59 p.m. CST on September 11, 2021 (the "Sweepstakes Period"). The Co-Sponsors' time clock will be the official time keeping device for this Sweepstakes. All entries must be received by 11:59 p.m. CST on September 11, 2021. All interpretations of these Official Rules and decisions made by Co-Sponsors relating to the Sweepstakes are final.
- 2. Eligibility: To be eligible to enter the Sweepstakes you must be a legal resident of the United States residing in the state of Wisconsin and at least 18 years of age at time of entry. Employees, agents, and directors of North Shore Bank, and Shorewood BID (the "Co-Sponsors"), and Margle Media, LLC (the "Administrator"), and their respective parent companies, affiliated companies, subsidiaries, partners, sponsors, advertising agencies, promotion agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes (the "Sweepstakes Entities"), and their immediate families (i.e., parents, spouse, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to enter or win the Sweepstakes.

By completing these tasks, entrants will earn one (1) entry into the Sweepstakes. There is a limit of one (1) entry per person during the Sweepstakes **Period.** In the event of a dispute over the identity of the person who submitted a winning entry, the information entered at northshorebank.com/shorewoodgiveaway.com will be deemed to be the entrant. It is the sole responsibility of the entrant to notify the Administrator in writing if the entrant changes his or her Facebook or Instagram account during the Sweepstakes Period. The "authorized account subscriber" for online entries is defined as the natural person who is assigned a social media account by a social media platform provider, online service provider or other organization that is responsible for assigning social media accounts or handles for the account associated with the submitted Facebook or Instagram account. In the event a winning account selected is a joint account, a total of one (1) Prize will be awarded in the name of the information entered at northshorebank.com/shorewoodgiveaway. Proof to Sponsor's satisfaction of being the

- 7. Prizes: One (1) Prize will be randomly awarded in total. Prize consists of six (6) \$50 gift cards to use at local restaurants. The Approximate Retail Value ("ARV") of the Prize is \$300. All federal, state, and local taxes on a Prize are the sole responsibility of the Winner. Prize is not transferable, and no substitution or cash equivalent is allowed, except in Co-Sponsors' sole discretion. Co-Sponsors reserve the right to substitute prize of the same approximate retail value if advertised Prize becomes unavailable for any reason. Prize consists only of items specifically listed as part of the Prize. Winner is responsible for all costs and expenses associated with Prize acceptance and use that are not specified herein as being awarded. Prize dates are subject to change in Sponsor's sole discretion. within **three business (3) days** of initial e-mail and/or does not meet the eligibility requirements, the potential Winner will be disqualified, and an alternate potential Winner will be selected in a random drawing from among all of the remaining Eligible Entries.
